- (a) If the resolution of the Governing Body of the college is found to be incorrect / defective or if any procedural lapse is detected regarding selection of the candidate, the approval of appointment of incumbent(s) concerned will be cancelled without any notice;
(b) If there is / would be any Court Case against the Selection/Advertisement, etc., the appointment should be subject to the outcome of the court case / legal proceeding;
- The proposed regularization is governed as per provision made vide O.M. No.B(2)H.97/2003/98, dated 17-07-2004.
- The incumbent(s) working under Non-Sanctioned post & who is adjusted against the post is/will be personal to the incumbent(s) and automatically be abolished after the retirement of the incumbent(s) concerned.
- The adjusted Assistant Professor(s) will be entitled to get UGC's scale of pay Rs.15,600-39,100 + AGP Rs.6000 with other allowances as per rule as admissible from the date of regularization.
